

### What is College Credit Plus?

College Credit Plus is Ohio's dual enrollment program where students earn both high school and college credit at the same time

- Students may apply to any public or participating private college
- Students may apply to multiple colleges
- Students may take classes from multiple colleges during the same time period

### Who is Eligible?

- → Students in grades 7-12
- → Ohio residents
- → Students who meet academic eligibility standards, (determined by the State)
- → Students who have maintained satisfactory completed of CCP courses/GPA (returning CCP students)
- → College Ready students

## What does it mean to be "College-Ready"?

#### More than just academically ready

- ◆ Emotional and social transition
- ◆ Meeting college expectations
- ◆ Time management and organizational skills
- ◆ Ability to self-advocate
- ◆ Some college classes have content that is oriented toward a mature or adult student. College instructors will not modify the course content for CCP students.

Ohio requires new CCP students and parents to complete a Mature Content Permission Slip.

## <u>FERPA</u>

- The "Family Education Rights and Privacy Act"
  - Protects student education records
    - Parents do not have access to student's academic records
    - Colleges reserve the right to communicate student record information with appropriate high school officials who have an "educational need to know"
    - "Permission to Release Information Form" student's written consent to share information with a third party
      - For example: for *Lakeland*, this <u>must be student initiated</u> with photo ID at the Student Service Center

#### What are the **Benefits** of CCP?

#### Students can:

- Earn high school & college credits at the same time
- Get a "head start" on career plans
- Start & potentially complete a degree or certificate program
- Understand the expectations of college life
- Save tuition & textbook costs
- Demonstrates to colleges that you are "college ready"

#### College Credit Plus (CCP) or Advanced Placement (AP)

## CCP Ohio's dual enrollment program that offers students in grades seven through 12 the opportunity to earn both high school and college credit at the same time. both high school and college credit at the same time.

## CCP Eligible seventh through 12th grade public school students can take up to 30 college credits free per academic year. There may be a fee applied to take the AP exam.

## CCP Courses are offered at Lakeland's campus, Lakeland's partner high schools or online. CCP Courses are offered at the high school's campus.



#### **How Many Credits can Students Take?**

- Up to 30 credits per academic year, includes high school classes:
  - $\circ$  Calculation: 30 ( \_\_\_\_ high school units x 3) = \_\_\_ (max CCP credits)
  - $\circ$  Example: 30 (3 high school units x 3) = 21 CCP credits
- If a student enrolls in more than 30 credits, they can either:
  - O Drop the course (during the 100% refund period) or
  - Pay for the <u>entire</u> course (including tuition, fees, books) at the college's standard rates

#### When Can Students Take Classes?




- Summer is the lead academic term
- Student athletes should know summer term CCP courses cannot count for athletic eligibility for that academic year

\*The option to take courses at the high school is only available if the high school has partnered with a college or university to offer courses at the high school. At Chardon High School, this partnership is through Lakeland Community College.

#### What Courses can Students Take?

- College courses in subject areas that will satisfy high school graduation requirements
  - Students must work with high school counselors to ensure they are meeting any mandatory testing or other high school requirements
- Courses in a career pathway that interests them
- Courses that are major or degree requirements
- Students must meet prerequisites for all courses they take
- Students must complete their first 15 credits in Level I courses, which are transferable to public Ohio Universities. (See College/University's website for a list of Level I courses)

#### Non-Allowable Courses

 Private applied courses with one-on-one instruction (such as performing art lessons)

Study abroad courses

Physical education courses

Pass/Fail graded courses

Remedial courses or sectarian/religious courses

#### **Grades & GPA**

- CCP grades earned in college courses are the same grades that will appear on the high school transcript
  - Chardon- A "W" or "Withdrawal" is not placed on the student's HS transcript
- Grades will be factored into the high school and college GPA
  - Weighted Grades\*
    - "Secondary schools must implement a policy for awarding grades that is equivalent across all advanced standing courses in the same general subject area"
    - Chardon Potential Policy:
      - Grades of C or higher will be weighted with an additional value of 1 added for AP/CCP
      - **Ex.** a final grade of A = 5.0 quality points, B = 4.0 quality points, C = 3.0 quality points

If a student fails or withdraws from the course, the college transcript and high school transcript will reflect the student's final grade.

#### Will my Credits <u>Transfer</u>?

- Most courses will transfer, especially from one public college to another public college within Ohio
- Students must check with colleges to confirm transferability

## **CCP Probation & Dismissal**

Lakeland allows students to withdraw from a course within the first 2 weeks for a full refund.

- If you a fail a course, you will be billed for the cost of the course and the textbooks
- If you register for a course, drop the course with Chardon, but forget to drop it with Lakeland
  officially, you will (likely) be billed for the cost of the course and the textbooks
- If you withdraw from a course after the first 2 weeks, you will be billed for the cost of the course and the textbooks
  - Roughly \$60/credit for courses taught at Chardon by our staff
  - Roughly \$120/credit for courses taught via the college/university staff

#### What <u>Support Services</u> are Available?

- High School counselor
- College advisors/counselors
- Colleges provide the same academic supports to CCP students as they do traditional students
  - Learning Center/Tutoring
  - Library Access
  - Advising/Counseling
  - Student Accommodation Center

#### **How do I qualify for CCP?**

- Students entering grades 10, 11 or 12 with an unweighted, cumulative high school GPA of 3.0 or above will be admitted into the CCP program.
- Students entering grades 7, 8, and 9 must submit qualifying ACT or SAT scores or take the Next-Generation ACCUPLACER Writing test at Lakeland (or the college they are applying to) and test into college-level English.

<sup>\*</sup> Students who are entering  $7^{th} - 9^{th}$  grades, as well as students who do not meet the minimum GPA requirement must submit an eligible ACT, SAT or ACCUPLACER test score to be admitted to the CCP Program.

- Attend (watch) a <u>CCP Informational Session</u> / complete attendance form
- ☐ Complete CCP Intent to Participate Google form by April 1, 2024
- ☐ Apply online at lakelandcc.edu/apply (or college of your choice)
- ☐ Complete the CCP Permission Slip (typically done as part of online application)
- Request CHS transcript from Mrs. Giddings
- ☐ Send <u>ACT scores</u> or schedule Accuplacer, if applicable
- ☐ Check your **personal email you applied with** for your acceptance confirmation
- Once accepted, complete <u>CCP Online Orientation</u> (check your **college email** for this)
- ☐ Meet with Lakeland counselor (new CCP student only) to schedule your classes
- ☐ Meet with Office of Accessibility (if applicable) for students on <u>504 or IEP plans</u>
- Register for your courses by May 1, 2024 (all CCP application materials must be complete at this time for our in-house classes).

## Intent to Participate Form

- Students must complete the Intent to Participate form and submit it to their high school by April 1, 2024
- This is the only way CCP students can receive state funding
- Not a binding contract & students can decide not to participate even if they sign it.
- This form is separate than the college application
- On the Intent to Participate form, students indicate a tentative plan to use Option A or

Option B for payment of the College Credit Plus courses





## APPLICATION PROCESS & ORIENTATION REQUIRED MATERIALS MAY DIFFER BY INSTITUTION

- Meet state eligibility standards
- CCP Application (only new applicants)
  - Returners will fill out CCP Continuation Form via their KSU email in February
- SAT/ACT scores or Accuplacer scores are an optional credential. As an applicant, you can decide if you want to submit as part of your application.
- Official HS transcripts
- Recommended 3.0+ GPA
- CCP Permission Form
  - Signed by student and parent

#### Kent State Application Deadlines

- Summer 2024 April 15
- Fall 2024 June 1
- Spring 2025 Oct 15

#### **Attend Mandatory Orientation**

 Regardless of location of class, all new students must complete orientation.
 Returning CCP students must schedule an advising appointment.



## IN SUMMARY...

- Complete and submit the Letter of Intent no later than April 1 for 2024-2025 school year
- Apply for CCP to college(s)/university(ies) by application deadline
  - Provide all transcripts, required test scores, and permission forms
- Let colleges/universities know if you move or your information changes
- Know the deadline dates for each college/university
  - Application deadlines including ACT/SAT/Accuplacer test deadlines
  - Orientation Program dates
  - Course registration and withdrawal deadlines
- Let colleges know if you have an emergency that impacts your participation in CCP
- Remember that the college records belong to YOU, the student
  - For your parents to have any access, you need to provide a FERPA release
  - The courses you take under CCP start your permanent college transcript
  - You, the student, are the only person who can request your college transcripts

# COLLEGE CREDIT PLUS ADMISSION REQUIREMENTS

- ► Preferred Cumulative (Overall) GPA of 3.0 in High School Courses
- Standardized Test for Course Placement
  - ACT or SAT
  - ► Reading Accuplacer at Lake Erie College
  - ► Test score is not required if GPA is above a 3.0 and student is entering 10th, 11th, or 12th grade
- Application for Admission (Available Online)
- Guidance Counselor Recommendation Form (Available Online)
- ► Mature Content Consent Form (Available Online)
- Release of Educational Records Form (Available Online)

# WHAT COURSES CAN A CCP STUDENT TAKE AT LAKE ERIE COLLEGE?

- ► If the student meets the prerequisites for the coursework, all undergraduate coursework is typically available for CCP Students to enroll in.
- ► Some restrictions may apply based on course placement or area of interest.

## **DEADLINES FOR LAKE ERIE COLLEGE\***

- April 15<sup>th</sup>: Deadline to Apply to Lake Erie College
- May 17th: Deadline for Accuplacer (if needed)
- May 31<sup>st</sup>: Deadline for Course Registration via LEC Academic Advisor
  - This is for students taking classes through Lake Erie College and not through a partnership program with their high school.
- ▶ To Be Determined: Mandatory College Credit Plus Orientation
