

WELCOME TO CHARDON HIGH SCHOOL SKI/SNOWBOARD CLUB

To prospective members of Chardon High School Ski/Snowboard Club:

Ski/board season is getting closer. Are you joining your friends who are going skiing with CHS Ski/Snowboard Club? All students in ninth through twelfth grade are welcome to join.

This year we are skiing on Tuesday evenings. We will leave Chardon High School promptly at 4:10. Upon arrival at Brandywine, we will be met by our Ski/Board School Instructors and then proceed to the equipment rental area to select our equipment and check in. Those with ski/boards will go right to the Ski/Board area. You will have four hours to enjoy the slopes every Tuesday. All participants must take 5 lessons. Lessons are included in the club program package, so no experience is necessary to join.

All Ski/Board club members are responsible for keeping track of the time. Ski/Board members will be called off the slopes at 9:15 pm. All members should be back in the rental shop early so that they can be on the bus at the time we are supposed to be leaving for Chardon. Anyone who causes delay could be suspended from the next bus ride, or from further bus rides, without a refund of money.

All students who ride the bus from Chardon to Brandywine must also return to Chardon on the same bus on which they are assigned. There are no guests or occasional riders allowed on the busses. Anyone who rides the bus must be a member of the Chardon High School Ski/Snowboard Club. While riding the bus, all school rules apply. We must leave the bus as clean as we found it. You membership fee does not include a charge for cleaning the bus. No drinks or food will be permitted on the bus, either going or returning. This is state law.

The Ski/Board passes issued by Brandywine can only be used by the person whose name appears on the ticket/card. If you get caught lending or borrowing a pass, the pass is confiscated and no money refunded. If you should misplace your pass, go to the ticket office and request a new one for a replacement fee. (This can only happen once in the five weeks).

All students are reminded that the Chardon High School Ski/Board Club is a school function, under school sponsorship, and all school rules are in effect and strictly enforced. Persons caught smoking, drinking, partaking in any type of inappropriate activity are suspended from the Ski/Snowboard club and disciplinary consequences will apply. Any person caught creating any problem or source of embarrassment for Chardon, the Ski/Snowboard club, shall be dealt with severely. No refunds will be issued to any student removed from the club due to disciplinary reasons invoked by the school advisor, Brandywine Ski/Board Patrol, or Brandywine management.

You represent Chardon, so embody the core values in the decisions you make on Tuesday evenings during the club time. Chardon High School Ski/Snowboard Club is to be fun for everyone and a hassle for no one!
